Members confirmed receipt of the Clerks report

CLERK REPORT October 13th 2020.

Whitehaven Skips. A further email has been sent to the site agent asking for an update on the situation with Whitehaven skips and the quotes received from Cumbria Waste Management to clear the site. No reply has been received as yet.

Kangol Site/Cleator Mills. Communication has been forwarded to members regarding a possible application for housing on the site, no application has yet been lodged with CBC

Cleator pitch. As reported there has been damage caused to the pitch leased by Cleator Moor Celtic for their youth teams. Securing the site has been discussed once again and can be further discussed when the new lease is to be signed next year.

Todholes Road Garage Site No reply to the request for an update following CBC environmental health site meeting with the garage tenant, this will be followed up. I have received no reply to the latest letter sent to the tenant and this will also be followed up.

Bins. Following the meeting with CBC waste manager the two CBC bins on the Square have not been removed or repaired, a request for an update has been sent. The big hill bin is to be put back and concreted in place however this is also outstanding and has been followed up.

Allotments Sympathetic reminders have been sent out to all outstanding allotment holders and will be followed up during the next few weeks. When practicable a visit to the high st allotment sites with at least 1 member would be useful.

Mill Hill Further concerns have been raised by residents of Mill Hill regarding a tenant, a request has been sent for information from the meeting that was planned with Environmental health and Home Housing in September. As of yet no further information has been received from Home housing regarding the issues with the road surface on the estate and the pavements.

EDF Energy The billing issues with EDF are still ongoing, following the promise in August promising the bills would be amended to recognise the correct meter readings I sent in I have received another bill this week that has the same problems and as such payment is still being withheld on this. I have contacted edf to ask for this to be sorted asap, these issues have been ongoing since the account was transferred to them in January.

Anti- Social behaviour Following several reports to the police regarding the growing concerns of anti- social behaviour around the town several names were taken by the police last weekend when a large gathering was dispersed and moved away from the square. Concerns have also been raised with regards to the welfare of an adult and this is being dealt with by specialist officers.

Councillor Eldon confirmed that the vision statement for the Town Board was complete. He also informed members that leaflets had been printed and would be distributed in the town asking for residents views on what they want for the town. An online survey had also been set up and that the Town Board long list of ideas was being whittled down.

361/20 To discuss the planning white paper 'Planning for the Future'

The response by NALC to the planning white paper has been distributed to all members. The following concerns were raised by Councillor Dorgan regarding NALC point on page 2 that it does not align with the Climate change agenda. It was pointed out that throughout the white paper is bearing in mind sustainability and the governments target to reduce carbon emissions to net zero by 2050 and that all planning applications would be required to meet 1 uniform statutory test regarding sustainability.

Resolved that these be noted.

362/20 To discuss the requests from Todholes Road residents regarding the purchase of gardens.

Resolved to look into issues relating to costs and legalities and to add to a future agenda.

363/20 To discuss the CBC footway lighting proposal.

Resolved that more information is needed from CBC regarding condition of lights, running costs etc before any discussions can be started. CMTC will also follow the guidance from CALC on this issue.

364/20 To discuss the request from Cumbria County Council health and well being coach regarding use of the meeting room for client meetings.

After discussion and with awareness of the current climate it was resolved that the request be declined at this stage.

365/20 Update on Remembrance Sunday arrangements.

Following a meeting with the Royal British Legion representative and the Clergy it has been agreed that there will be no parade or service at St Johns or the Market Square this year. Laying of the wreaths will be arranged individually and a service from St Marys will be live streamed at 3pm on Social media and shared with the other churches.

Resolved that the crib will be placed as usual on the Market Square at a date to be confirmed. Cllr Denwood will arrange for knitted figurines to be produced by Volunteers.

Great North Air Ambulance. Resolved to award a grant donation of £500.00

Cleator Moor Born and Bred Podcast. After discussion it was resolved to ask for further information relating to the set up and current legal status of the group, where would the funding be sent if the Group do not yet have a bank account. Further information also required about actual audience numbers on a weekly basis and what the group hope to achieve. It was noted that face book statistics on these are not accurate and do not

represent true figures. Further details regarding ongoing costs and overall viability of the group were requested.
